LIMITED WARRANTY

EXCLUSION OF PURCHASER'S WARRANTY OR LIMITED WARRANTY

The Limited Warranty ("Warranty") provided herein supersedes and voids any warranty or limited warranty provision contained in any of Purchaser's documents relating to Purchaser's purchase of the product from The Gyro House (hereinafter referred to as "TGH").

MODIFICATION OR CHANGE

TGH hereby warrants to the Purchaser that the product will be free from defects in workmanship and material for the period set forth below.

The following warranty time periods shall apply:

(FN)	Factory New	Original equipment manufacturer's warranty
(AR)	As Removed	No warranty other than unit is repairable
(OHC)	Overhaul	TWELVE MONTHS from date of shipment or one thousand flight hours, whichever occurs first.
(R)	Repair	Three months from date of shipment or one hundred flight hours, whichever occurs first. The company's liability on repairs is limited to parts and labor on the portion that has been repaired.

CORRECTION OF DEFECTS

If, during the Warranty Period, a defect in workmanship or material renders the product unserviceable, TGH will correct the defect by either repairing or replacing, at TGH's option, any product sold by TGH and returned to TGH during the Warranty Period (refer to "Conditions").

DETERMINATION OF DEFECT

TGH will determine if any defect in workmanship or material has occurred within the coverage of this Warranty. Any product which is found to be defective will either be repaired or replaced in accordance with this warranty.

A new Warranty Period is not established for the repaired or replaced products. Such are warranted for the remainder of the Original Warranty Period only.

If a product is determined not to be defective, TGH will return such product to Purchaser and, in its sole discretion, **TGH may charge Purchaser for all costs incurred in the inspection and return shipment of the product.**

CONDITIONS

TGH's warranty obligations described herein are subject to the following conditions:

- The warranted product has been used under normal operating conditions as established by the original product manufacturer and has not been subject to misuse, neglect, accident or improper handling, installation, maintenance or application;
- The warranted product has not been altered or repaired by anyone other than TGH or its designee;
- Purchaser, within the Warranty Period, notifies TGH in writing and within thirty days after such defect is discovered of any claim of defective workmanship or material and the basis for such claim;
- This warranty **expressly excludes** from its coverage **any labor charges** for removal of the defective product and the installation of the repaired or replaced product.

TRANSPORTATION
